

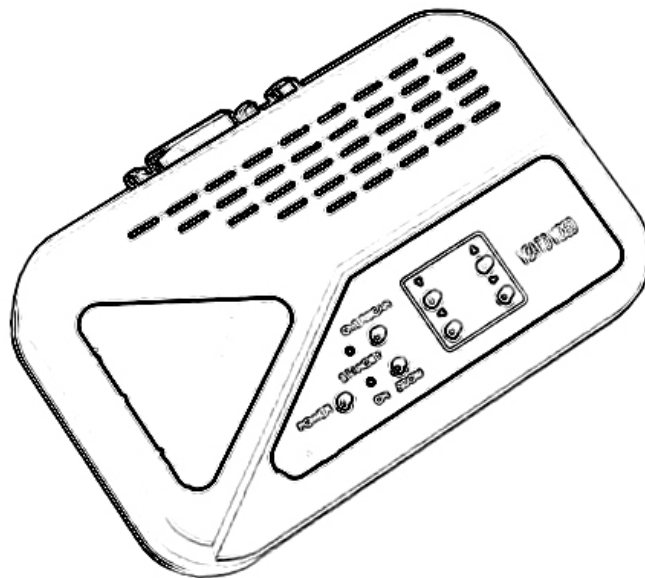

Introduction

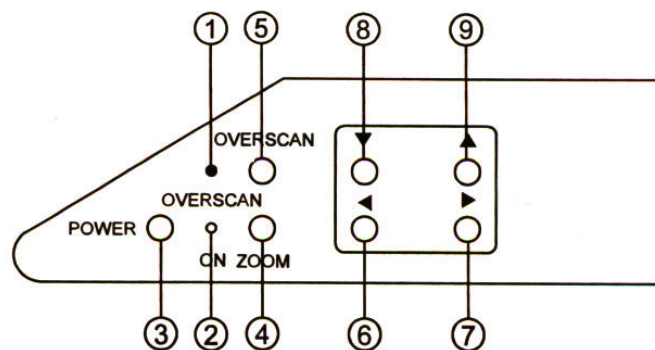
Thank you for purchasing the LINDY VGA to TV Converter. This device allows you to view the output from a VGA Video port on any PAL compatible TV or projector for large screen viewing.

Features

- Compact desktop design
- Plug and Play no software driver required
- Compatible with PC and Mac computers
- Supports VGA modes, 1024 x 768, 800 x 600, 640 x 480
- Automatically adjusts scan rates from 50Hz up to 100Hz
- Simultaneous display on monitor and TV
- Composite, S-Video (S-VHS or Hi8) outputs supported (PAL)
- Dimensions: 145 x 95 x 35mm (WxDxH)

Operation Controls and Functions

1. **Standby indicator:** This indicator will light when the unit is in standby mode
2. **ON Indicator:** This indicator will light when in power ON mode
3. **Power Button:** Push this button to turn power ON or OFF
4. **Zoom Button:** Push this button to zoom the picture
5. **Overscan Button:** Push this button to overscan/underscan the picture
6. **Left Button:** Push this button to pan the picture left
7. **Right Button:** Push this button to pan the picture right
8. **Down Button:** Push this button to pan the picture down
9. **Up Button:** Push this button to pan the picture up

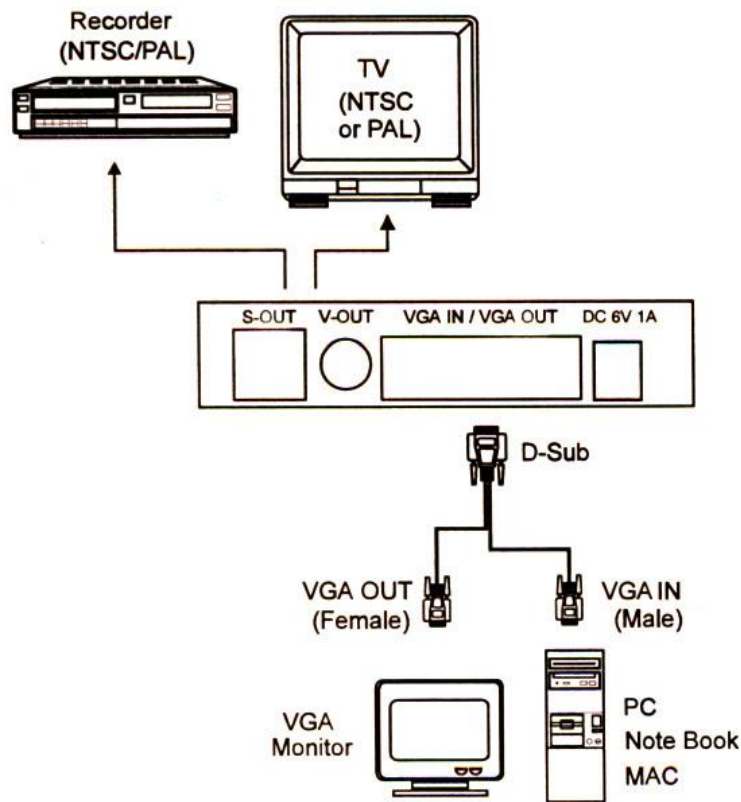


Installation

The LINDY VGA to TV Converter is a true Plug and Play device which does not require any software or drivers to operate. Simply attach the 15 way pass-through cable to the rear connector on the converter and then connect the 15 way HD male connector to your video card. Now simply connect the 15 way HD male cable from your monitor to the 15 way HD female connector on the pass-through cable. You will require either a composite video cable, or S-Video cable to connect from the converter to your TV or other compatible AV device.

Note: S-Video uses separate “Luminance” and “Chrominance “ signals and is the preferred connection method. If you’re TV does not support S-Video then use a composite cable.

Please refer to the diagram below for a typical application using the VGA to TV converter.



Power-Up Sequence

Ensure all equipment is turned off before connecting the VGA to TV converter. Once all cables are connected, apply power to the Television, then apply power to the converter and finally apply power to the source device.

CE Statement

**WEEE (Waste of Electrical and Electronic Equipment),

Dieses Gesetz verbietet vom 24. März 2006 an das Entsorgen von entsprechenden, auch alten, Elektro- und Elektronikgeräten über die Hausmülltonne! Diese Geräte müssen den lokalen Sammelsystemen bzw. örtlichen Sammelstellen zugeführt werden! Dort werden sie kostenlos entgegen genommen. Die Kosten für den weiteren Recyclingprozess übernimmt die Gesamtheit der Gerätehersteller.
